### PROTOCOL INFORMATION

Step 1	Microchipping (Speak to your vet)	<ul style="list-style-type: none"> <li>All pets must have an ISO approved microchip implanted subcutaneously.</li> <li>Tattoos are not accepted.</li> <li>Please inform your consultant if your pet has more than 1 microchip.</li> </ul>
Step 2	Vaccinations (Speak to your vet)	<ul style="list-style-type: none"> <li>Rabies vaccination is compulsory and must be older than 30 days but not older than 12 (twelve) months. Acceptable vaccines include Zoetis Defensor 3, Nobivac Rabies and Merial Rabisin.</li> <li><b>Dogs</b> should be vaccinated against Distemper, Hepatitis, Leptospirosis, Parvovirus, Adenovirus and parainfluenza.</li> <li><b>Cats</b> should be vaccinated against Feline Panleukopenia (Distemper), Viral Rhinotracheitis Calicivirus, and Leukaemia older than 30 days but not older than 12 (twelve) months.</li> <li>Pets arriving at or departing from Keringa Kennels require Nobivac Kennel Cough, Bronchicine or Pneumodog (<b>dogs</b>) and Nobivac BB intranasal (<b>cats</b>).</li> </ul>
Step 3	Veterinary Health Certificate (VHC) (Speak to your vet)	<ul style="list-style-type: none"> <li>Your pet/s will require a health certificate which is valid for 10 (ten) days.</li> <li>Our consulting vet can complete the VHC on your behalf by prior arrangement.</li> <li><b>Dogs</b> and <b>cats</b> must be treated for internal parasites (nematodes and cestodes) and external parasites (fleas and ticks) within 15 (fifteen) days of departure.</li> </ul>

Step 4	Submission to Petwings	<p><u>The following documents must be submitted to Petwings :</u></p> <ol style="list-style-type: none"> <li>1. Original, unaltered vaccination booklet for each pet</li> <li>2. Original microchip certificate for each pet</li> <li>3. 1 (one) original Veterinary Health Certificate (VHC) for each pet</li> </ol> <p><b>(Microchip ID must be noted on all the above documents)</b></p> <p>On the day of departure Petwings will submit these documents to the South African State Vet for certification and endorsement.</p>
Step 5	Clearance at destination	<p>It is advised that your pets arrive at their destination during the week and preferably during normal office hours. This will ensure timely clearance through Customs and the presiding State Veterinarian while avoiding additional charges.</p> <p>Where applicable and unless stated otherwise, the consignee is responsible for import Permit, Import Customs, and Clearance at destination.</p>
<b>Other important points to consider</b>		
<ul style="list-style-type: none"> <li>• Puppies and kittens may not travel to Argentina on their dam's vaccinations.</li> <li>• Puppies and kittens must be older than 12 (twelve) weeks and have their first rabies vaccination administered at 12 (twelve) weeks of age (3 months) and may then enter Argentina at 4 (four) months old.</li> </ul>		
<ul style="list-style-type: none"> <li>• For your pet's comfort during travel we encourage you to include a favourite blanket, soft toy, or old T-shirt with your scent, which we will place in their travel box.</li> <li>• Chemical and other strong sedatives are NOT ALLOWED.</li> <li>• Mild herbal remedies such as Rescue, CalmEze, catnip spray or other valerian root extracts are permitted.</li> </ul>		
<p>Please inform your Petwings consultant of any brachycephalic (snub nose) pets travelling as certain airline, routing and seasonal restrictions may apply.</p>		
<p><b>Dogs and cats</b> that have been within or resident in a 50-kilometre radius area of reported cases of African Horse Sickness and/or Rift Valley Fever diseases in the last three years cannot be exported to Argentina.</p>
