**PROTOCOL INFORMATION**

Step 1	Microchipping <b>(Speak to your vet)</b>	All pets must have an ISO approved microchip implanted subcutaneously. Tattoos are not accepted. Please inform your consultant if your pet has more than 1 microchip.
Step 2	Vaccinations <b>(Speak to your vet)</b>	Rabies vaccination is compulsory and must be older than 30 days but not older than 12 months. Acceptable vaccines include Zoetis Defensor 3, Nobivac Rabies and Merial Rabisin. <b>Dogs</b> should be vaccinated against Distemper, Hepatitis, Leptospirosis, Parvovirus, Adenovirus and parainfluenza - older than 30 days but not older than 12 months. <b>Cats</b> should be vaccinated against Feline Panleukopenia (Distemper), Viral Rhinotracheitis Calicivirus and Leukemia - older than 30 days but not older than 12 months. Pets arriving at or departing from Keringa Kennels require Nobivac Kennel Cough, Bronchicine or Pneumodog ( <b>dogs</b> ) and Nobivac BB intranasal ( <b>cats</b> ).

Step 3	Veterinary Health Certificate (VHC) <b>(Speak to your vet)</b>	Pet/s must be examined within 7 days of departure and found to be clinically healthy and fit to travel.

Step 4	Submission to Petwings	<p><u>The following documents must be submitted to Petwings:</u></p> <ol style="list-style-type: none"> <li>1. Original, unaltered vaccination booklet for each pet</li> <li>2. Original microchip certificate for each pet</li> <li>3. 1 Original Veterinary Health Certificate (VHC) for each pet</li> <li>4. Import Permit (Copy)</li> </ol> <p><b>(Microchip ID must be noted on all the above documents)</b></p> <p>On the day of departure Petwings will submit these documents to the South African State Vet for certification and endorsement.</p>

Step 5	Clearance at destination (Petwings can advise you)	<p>It is advised that your pets arrive at their destination during the week and preferably during normal office hours. This will ensure timely clearance through Customs and the presiding State Vet while avoiding additional charges.</p> <p>Where applicable and unless stated otherwise, the consignee is responsible for import Permit, Import Customs, and Clearance at destination.</p>

**Other important notes to consider**

Kuwait requires that puppies and kittens be vaccinated no younger than 3 months and wait for 30 days prior to entering the country.

- For your pet's comfort during travel, we encourage you to include a favourite blanket, soft toy, or old T-shirt with your scent which we will place in their travel container.
- Chemical and other strong sedatives are NOT ALLOWED.
- Mild herbal remedies such as Rescue, CalmEze, catnip spray or other valerian root extracts are permitted.

**Please inform your Petwings consultant of any brachycephalic (snub nose) pets travelling as certain airline, routing and seasonal restrictions may apply.**

Each person is allowed one Import Permit per year, restricted as follows: 2 cats OR 1 dog and 1 cat, OR 1 dog
